BE IT ENACTED BY THE PUTNAM COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM AS FOLLOWS:

TITLE: AN ACT TO AMEND SECTION 2.02 OF THE PUTNAM COUNTY CHARTER, IN RELATION TO LENGTHENING AND STAGGERING THE TERMS OF OFFICE OF THE COUNTY LEGISLATURE

Section 1. Section 2.02 of the Putnam County Charter shall be amended as follows:

Section 2.02

The County legislators shall be elected for terms of two years at the general election held in odd-numbered years, except as hereinafter provided:

- a. Commencing at the general election in November of 1989, County legislators from Legislative Districts Five, Six and Nine shall each be elected for a term of three years.
- b. Commencing at the general election in November of 1991, County legislators from Legislative Districts One, Four and Seven shall each be elected for a term of three years.
- c. Commencing at the general election in November of 1993, County legislators from Legislative Districts Two, Three and Eight shall each be elected for a term of three years.

Section 2. This law shall be submitted for the approval of the electors of the County of Putnam at a general election to be held on the 8th day of November, 1988. If this law is approved by the affirmative vote of the majority of the qualified electors of the County voting thereon at such general election, this law shall become effective on January 1, 1989.
