\* Corporations may contribute a maximum aggregate amount of \$5,000 in a calendar year. However, they are also bound by the individual contribution limits if those limits are less than \$5,000.

± Funds of a candidate and the spouse of the candidate spent on the campaign are not contributions and are not limited. However, they must be reported on the appropriate schedule(s). (EL 14-100 (9)(3); 14-114(8).)

\*\*The election limit for family members is an aggregate limit from all of the candidate's family (defined as the candidate's child, parent, grandparent, brother, sister, and the spouses of those persons). (EL 14-114(1)(a).)

£ Any one member of the candidate's family can contribute any portion of the family limit, or the entire amount of the family limit. However, any portion contributed reduces the amount of the aggregate that is left for the other family members to contribute. If one family member contributes the whole limit, then the limit has been reached and the rest of the family is prohibited from making any contributions.
