WHEREAS, by letter dated June 10, 2023, Russell Goff tendered his resignation from the elected position of Town Highway Superintendent which he has held since 2011; and

WHEREAS, the Town Board, with great regret given Mr.Goff's exceptional service to the Town of Patterson, is resolved to accepting his resignation; and

WHEREAS, the Town Board deems it appropriate and necessary to appoint an Acting Highway Superintendent, pursuant to and in accordance with Town Law Section 64(5), to fill the vacancy in said office for Mr. Goff's unexpired term and until a new Superintendent is duly elected and qualified; and

WHEREAS, the Town Board desires to appoint EDWARD FOSTER JR. to serve as Acting Highway Superintendent for the unexpired term as aforesaid; and

WHEREAS, the Town Board desires to appoint EDWARD FOSTER JR. to serve as Acting Sanitation Administrator for the unexpired term as aforesaid; and

WHEREAS, since EDWARD FOSTER JR. is a member of Putnam County Local #840, as Acting Highway Superintendent, will have the powers and duties of the Highway Superintendent but will not be authorized to address employee issues, including hiring, discipline and termination of Highway Department employees, without the approval of the Town Board; and

WHEREAS, while appointed Acting Highway Superintendent, EDWARD FOSTER JR. will receive a rate of compensation of \$40.50 for a base rate of pay.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Patterson hereby accepts the resignation of Russell Goff, with deep and heartfelt thanks for his service; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Patterson appoints EDWARD FOSTER JR. as Acting Highway Superintendent on the terms as detailed above; and

BE IT FURTHER RESOLVED, that the Town Supervisor is hereby authorized and directed to take all necessary steps to give effect rot foregoing resolutions.

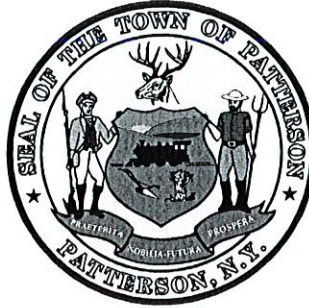
